

Edzell Woods Community Trust Sewage System Team Meeting Remotely via Microsoft Teams Friday 30th April 2021 at 6.30 pm

1. Budget for 2021

The sewage team were given a budget of $\pounds40,000$ to $\pounds45,000$ for STW brickwork, replacement yellow submarine pumps, water ingress at estate manholes, telemetry and a 2^{nd} wet well basket.

Contractors were consulted and visited the estate during the months of March and April and the following plan was proposed by Michael;

Michael asked if the sewage team were happy with the proposal to forward to the EWCT board of directors.

Brian explained that Gordon Smith's quote is an estimate as for a true quote the tanks would need to be emptied and that if a quote was provided but additional work was found to be required, the higher cost would be held accountable.



Brian asked about the landscaping sentence on the xylem quote and that we can do any landscaping works after Xylem complete the work ourselves.

Emil said that Xylem cannot put the vents into the wet well, which is a small disadvantage of the system being connected to a dry well so gas monitors are required.

Michael thanked Xylem for the highly discounted price.

Eriks quote – all agreed it was a pleasing quote and a 2nd basket would make the cleaning process much easier.

Emil said that for Drainflow MH23 (located in the play park) is the highest priority. MH1 and MH19 are surface water so not as high a priority for fixing. MH4 should be included in the 2022 budget.

Michael confirmed that everyone was happy and all proposed work is to be proposed to the EWCT board of Directors at the next committee meeting on Monday 3rd May 2021.
